Cash and Short-Term Investments

Currency deposits, money market mutual funds, short term government and corporate bonds and funds maturing in less than 1 year. Available in most major currencies.

Advantage: Stable, conservative with minimal risk of loss

Disadvantage: Lower returns


Bonds and Bond Funds

Intermediate and long term corporate and governmental bonds and bond funds from issuers in the US, Europe and Latin America. Credit spreads have widened in Q4, but are tightening into 2019.

Advantage: Stream of income with moderate market risk

Disadvantage: Some market value risk if interest rates rise rapidly, especially on longer bonds. Credit risk (risk of default) especially on high yield bonds.

Stocks and Stock Funds

Stocks and stock funds diversified across markets, industrial sectors and countries. US stocks are up 10+% in the past year, after experiencing significant volatility over the past 18 months. US markets have outperformed other global stock markets, on the unexpected resilience of US economic growth.

Advantage: Historically a larger long-term return for a larger amount of price risk **Disadvantage:** Stock prices can be unpredictable, and market valuations can vary significantly over time. Stock prices historically fall in 3 out of every 10 years, sometimes by more than 10%

Alternative Investments


Alternatives are defined as investment classes that do not fit the typical stock/bond classes, or that can have a performance that is typically uncorrelated to the movements of general markets.

Alternative investments include precious metals, commodities, real estate, petrochemical transmission limited partnerships, hedged long/short funds etc.

Advantage: Diversification out of typical equity market risk, or bond risk. Potential for higher returns **Disadvantage**: More idiosyncratic risks may be difficult to analyze. Risks may become more correlated in a general move to 'Risk Off'. Possibility of large price swings.
