- US Treasury bills and bonds with less than 1 year to maturity
- USD denominated, short duration investment grade funds with an average duration of less than 6 months
- BBB+ rated or better US\$ corporate fixed rate bonds with less than 1 year to maturity
- BBB+ rated or better US\$ corporate floating rate bonds with less than 3 years to maturity
- Certificate of Deposits protected by insurance from the FDIC
- Cash deposits in segregated brokerage accounts protected by the SIPC
